- drag king high femme

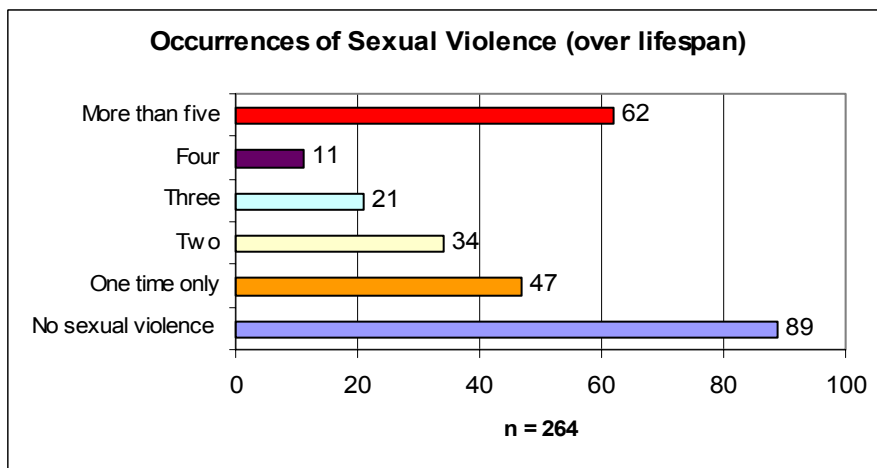

- I was abused by police on 2 occasions

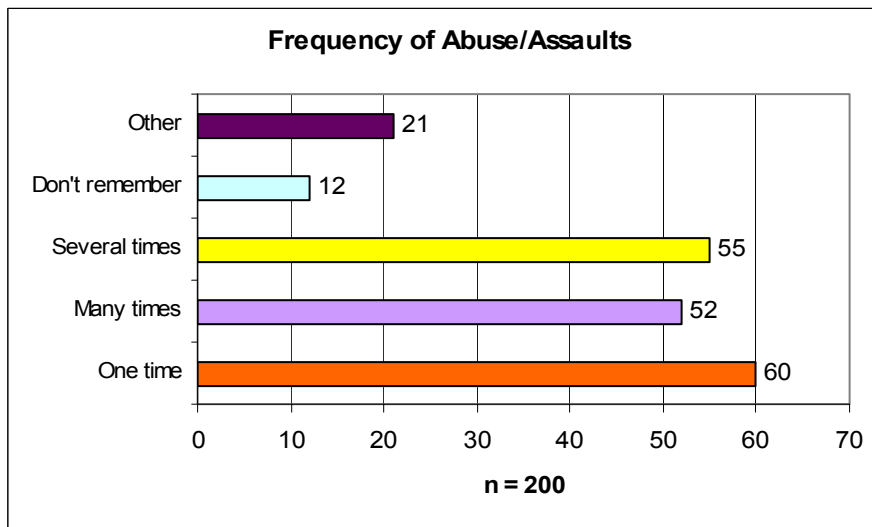

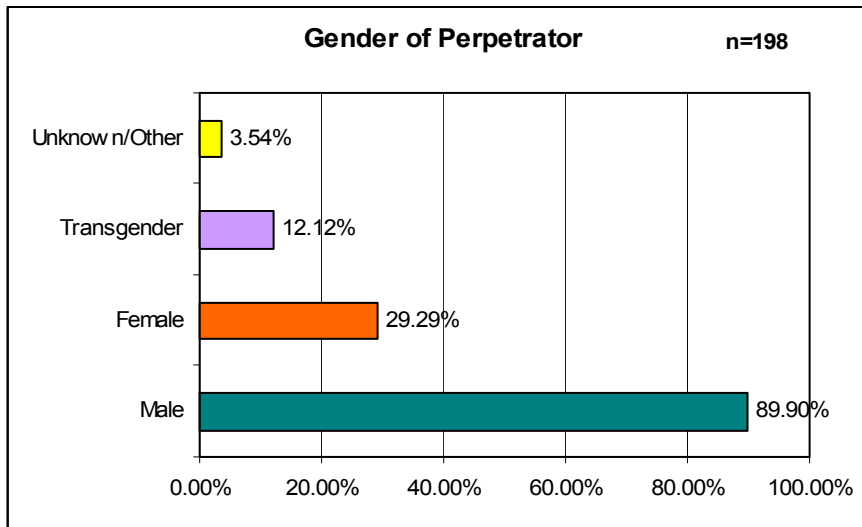

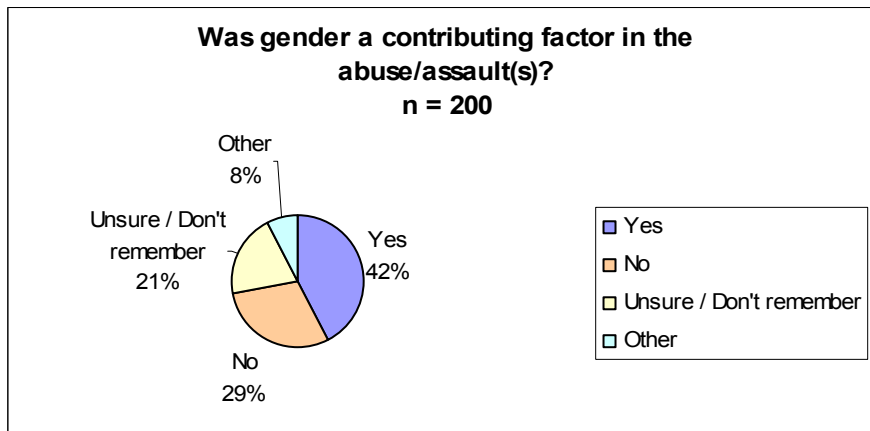
Other:

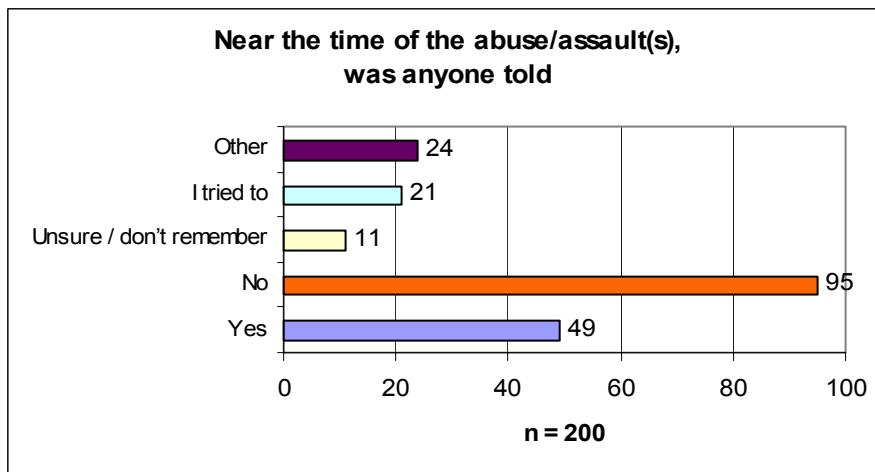

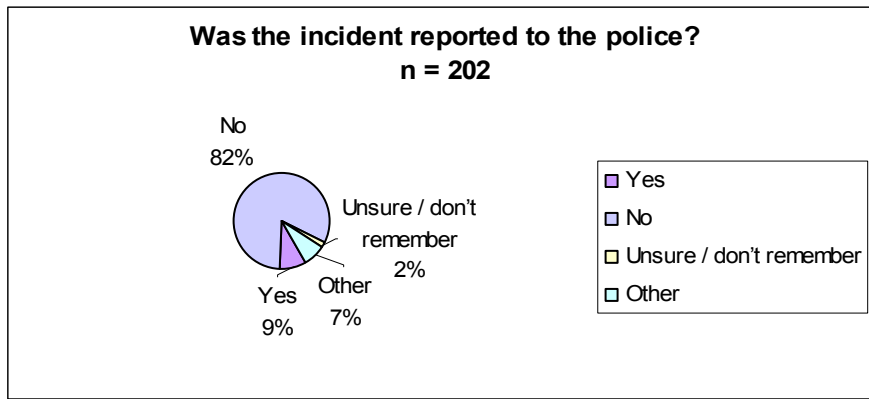

- in one instance, not until years later

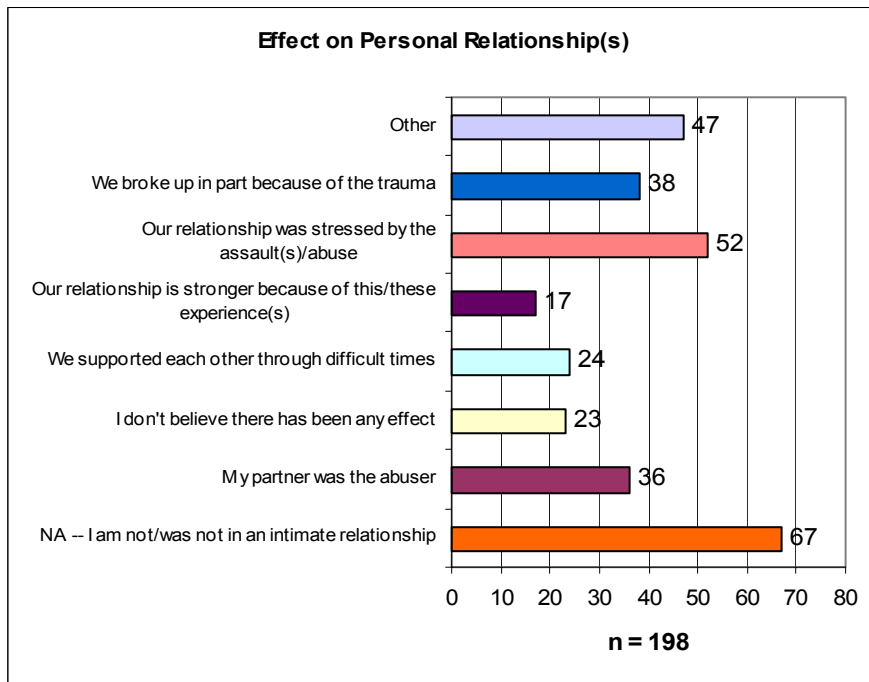

- eventually I had my father charged some 30 years later

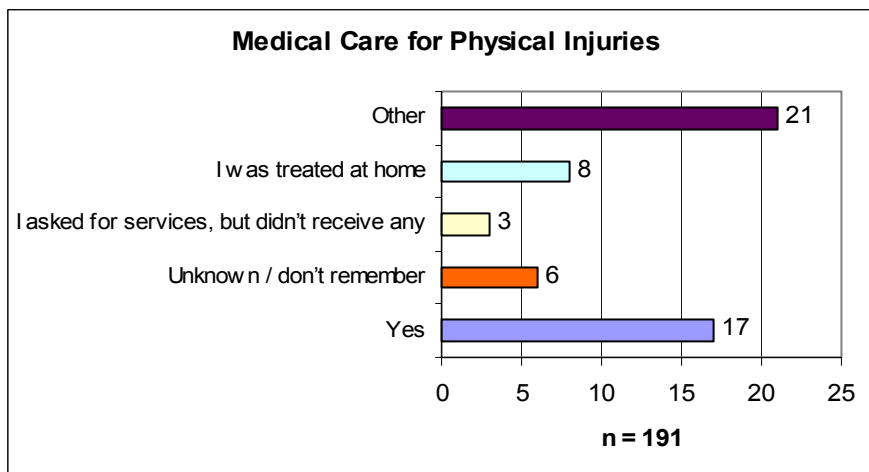

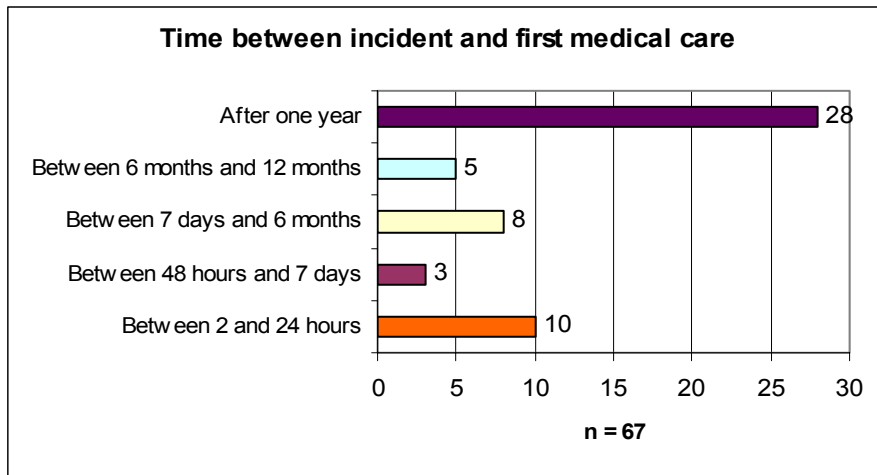
Other:

- I am sexually dead. My partner understands this.

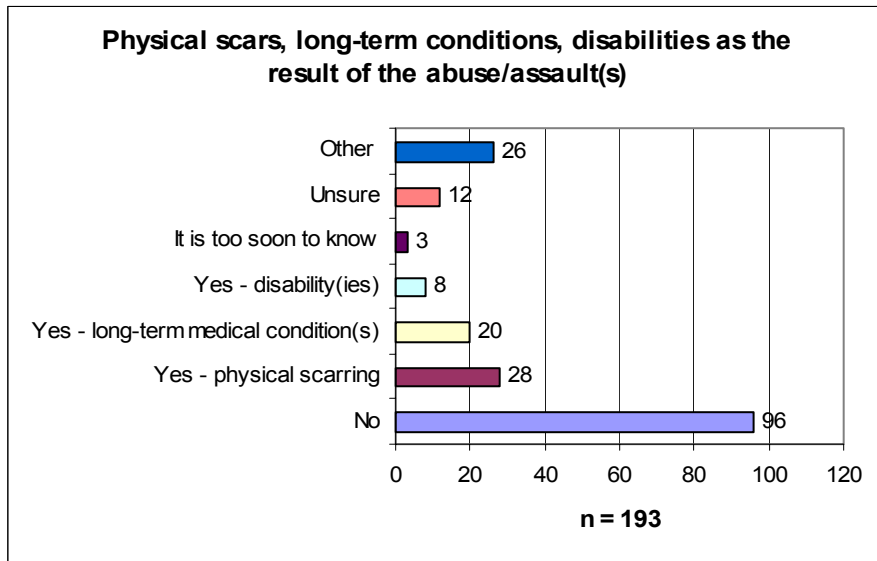

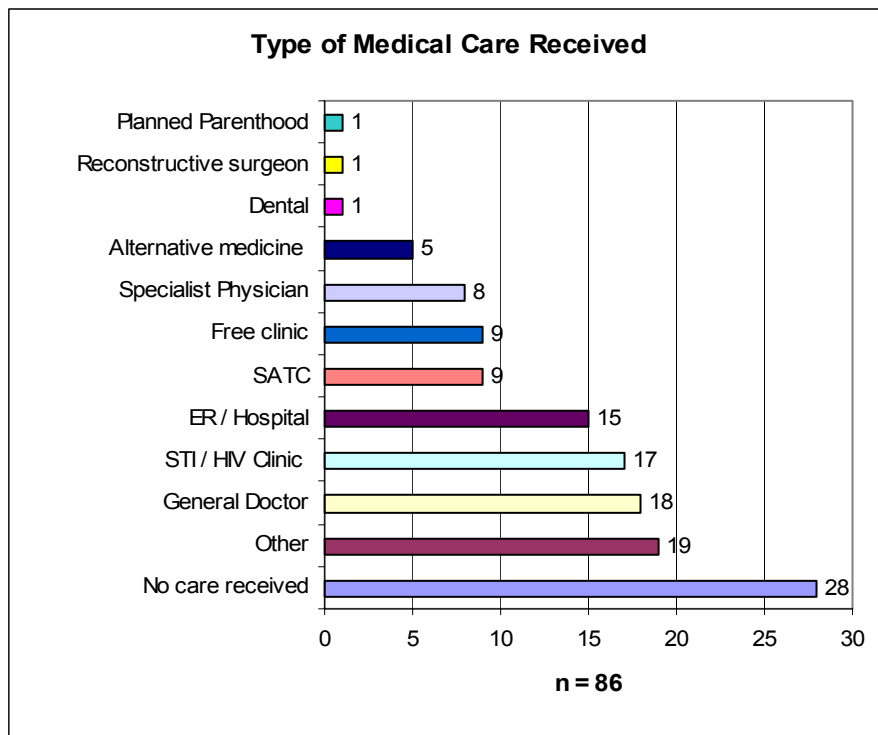

- I still have scar tissue around the vaginal opening

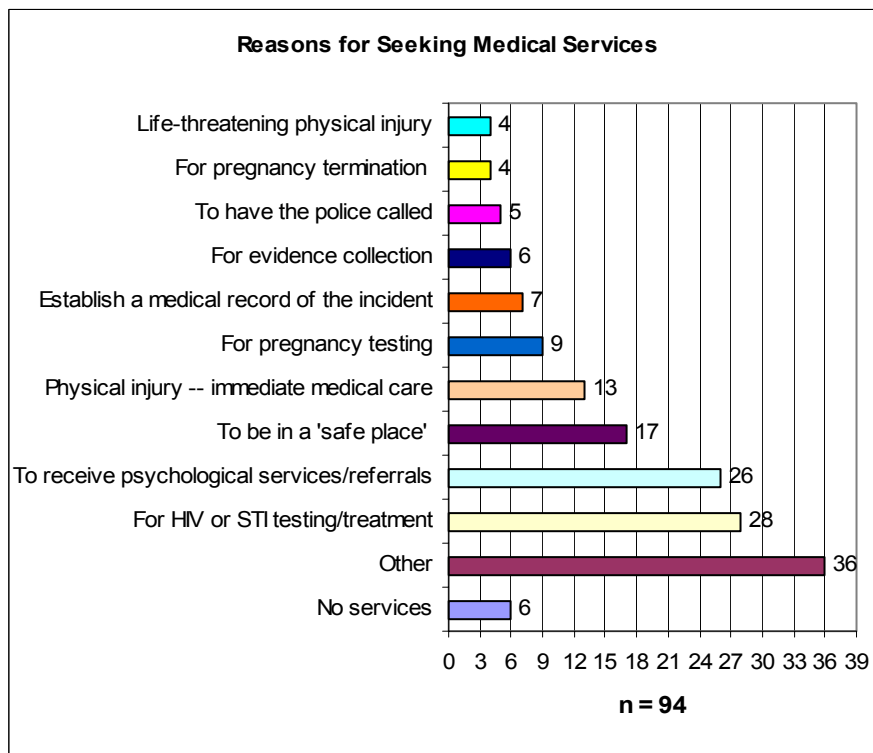

- mental not physical and not for 30 years

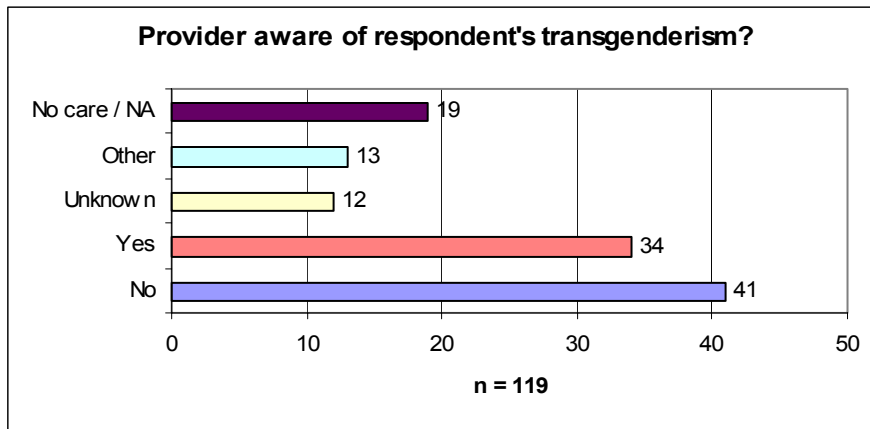

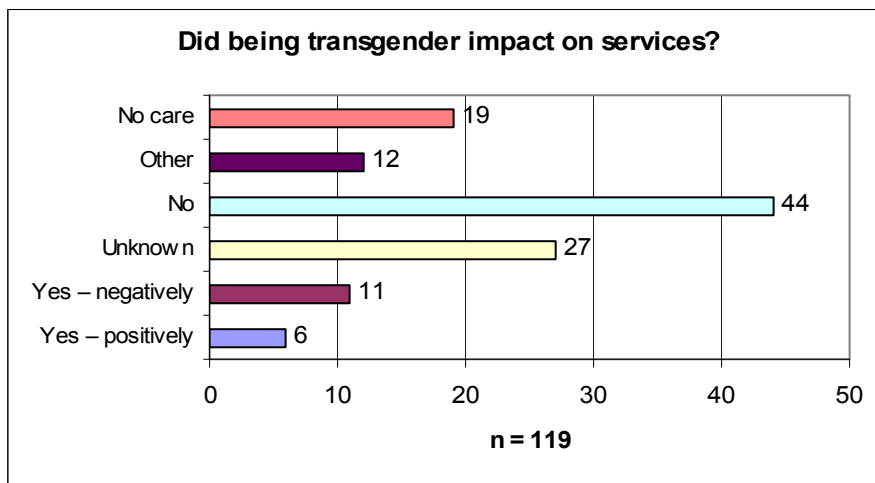
Other:

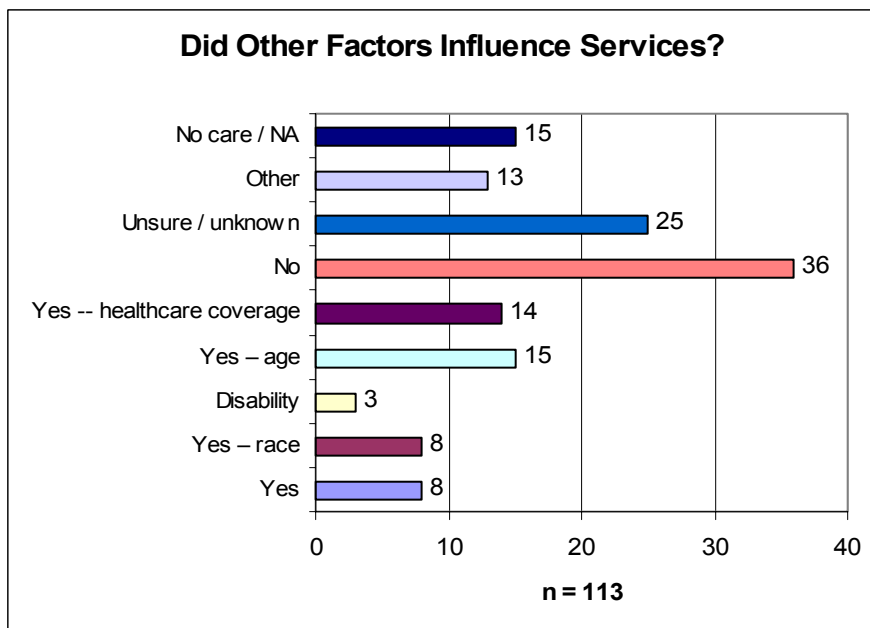

- Negative: I got much less support than I should've, as my guilt around transphobia was key to the abuse. Positive: I 'protected' him much longer because of the transphobia."

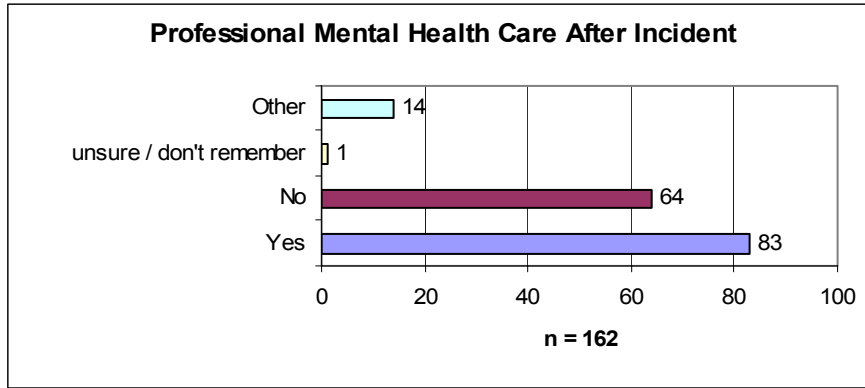

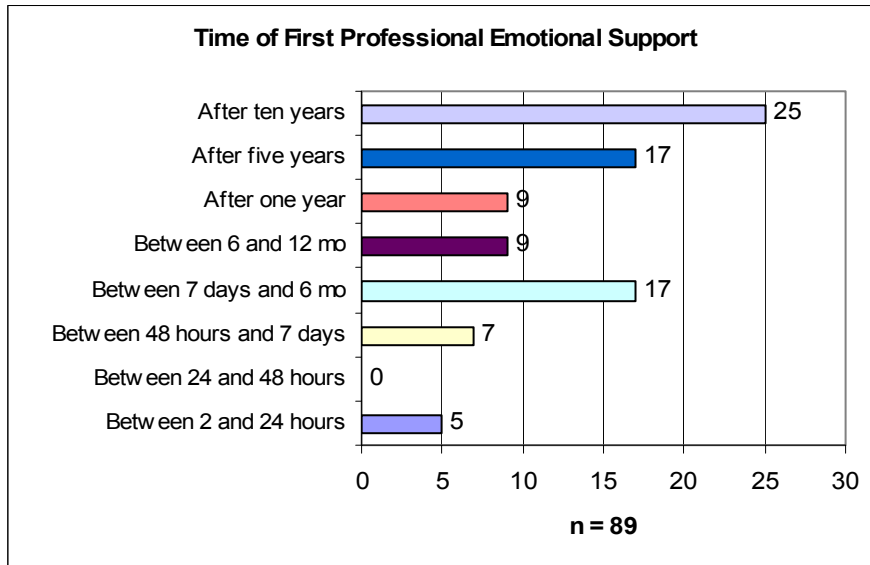
Other:

- yes-race (&sexuality): Being pathologized as a mixed-race bisexual, being the only bi&poc in my DV groups, not being able to afford long-term therapy

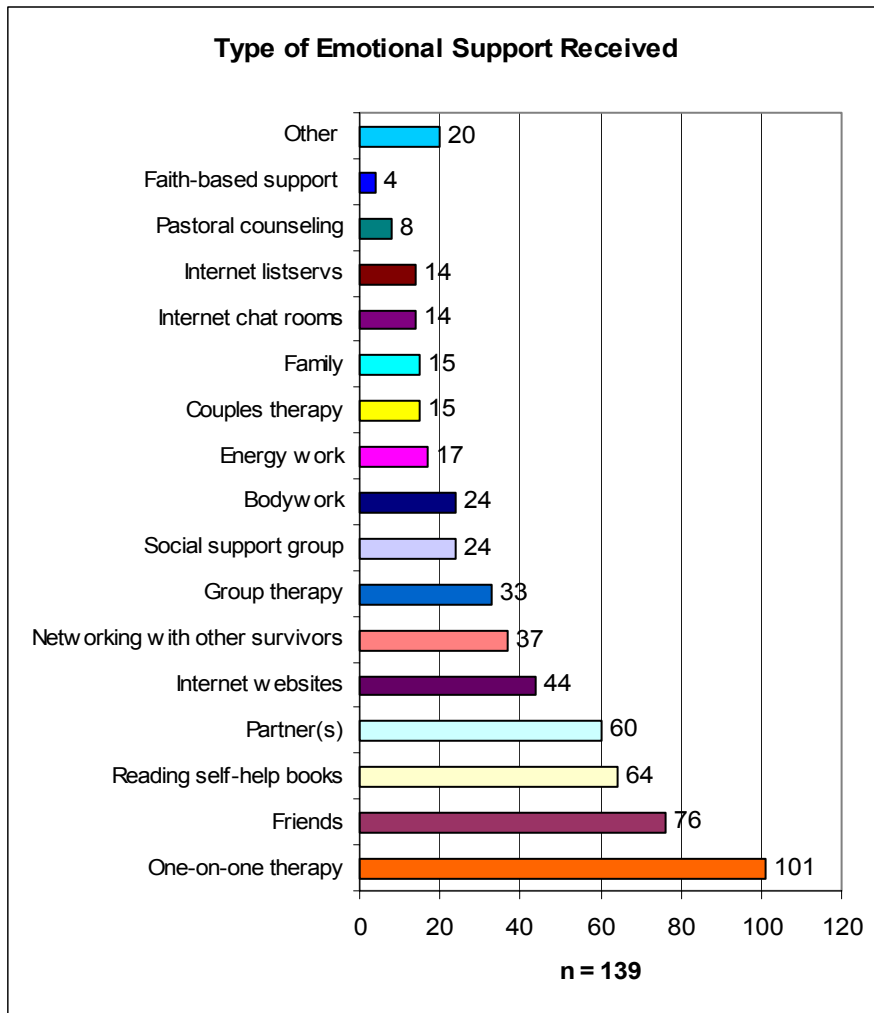

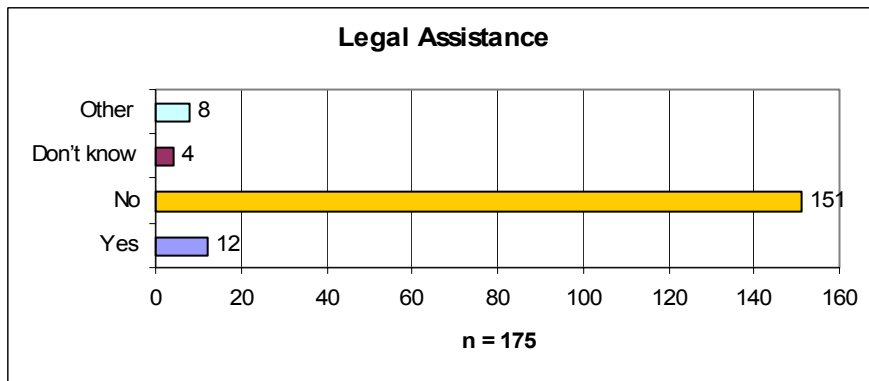
Other:
